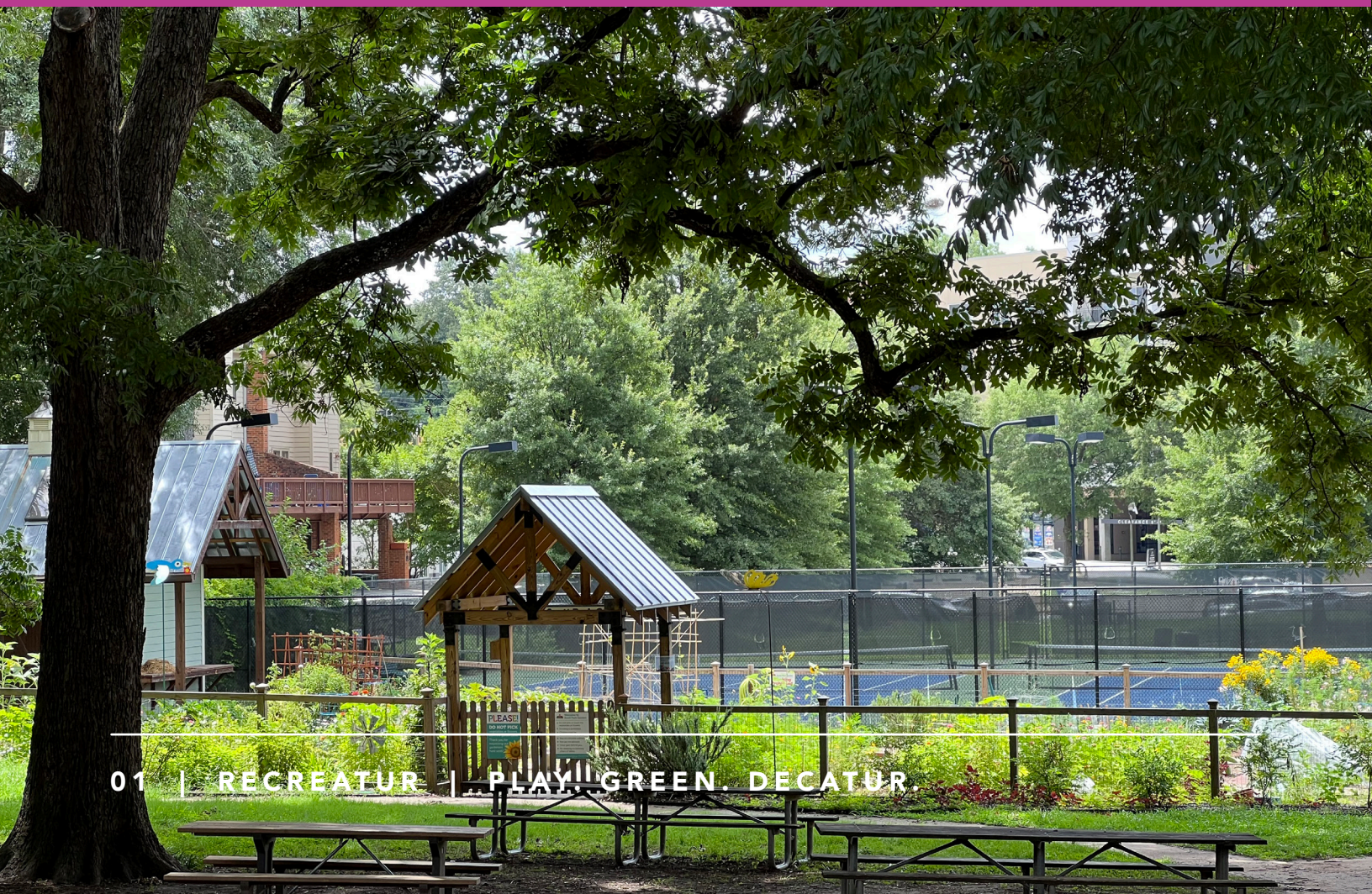

Benchmarking

Unlike other disciplines of city planning such as transportation or stormwater management, parks and recreation system planning does not rely on national standards. Rather, industry best practice encourages communities to benchmark their parks and recreation systems to other communities across the country with similar characteristics.

To that end, the National Recreation and Park Association (NRPA) developed Park Metrics, a database that contains the largest collection of parks and recreation operating data in the United States. Communities can use this database to benchmark and evaluate their performance against similar agencies and aggregated data from across the country.

For Recreatur, the Planning Team identified communities within NRPA Park Metrics that have a similar population and population density as the City of Decatur. These two characteristics are important because they inform city development patterns, which inform lifestyles and how residents may enjoy parks and recreation services. For example, cities with smaller populations may have different capabilities, policies, and procedures than cities with larger populations. Cities with higher population densities have more residents living in a defined geographic area. This may create a larger demand on, and for, parks, recreation facilities, and programs.

Additionally, increased densities may suggest smaller lot sizes and the presence of multi-unit structures versus single-family homes. Residents living in multi-unit structures typically rely more on public parks to provide basic, close-to-home recreational opportunities such as playgrounds, lawns to play catch, community gardens, or open spaces to allow dogs to run around without a leash. These are some of the basic, every-day recreational activities that a family living in a single-family home may enjoy in their backyard.

Finally, the benchmark cities were also limited to park systems with a comparable number of parks (10-39), to further capture similar systems.
